REVISED 2011-12 CALENDAR CHANGES
FROM NOVEMBER 22, 2011

Dear Parents,

We have had to make some very important last minute changes in the Tuckahoe Union Free School District 2011-2012 School Calendar.

I am providing you with the earliest possible notice so that you may adjust your personal schedules accordingly. We will also have periodic reminders of these upcoming changes.

Please make the following changes on your existing calendar:

May 2 and May 3, 2012
11 a.m. Dismissal

Therefore, Thursday, March 22, 2012 and Friday, March 23, 2012 will be full days of school for all students including Cottle elementary school students. Similarly, Wednesday, May 2, 2012 and Thursday, May 3, 2012, Cottle elementary school students will be dismissed at 11:00 a.m.

This is a required change to the first change announcement of May 3rd and May 4th.

Therefore, all students will attend a full day of classes on Monday, May 14, 2012 and Monday, May 21, 2012. Similarly, there will be no classes for students on Monday, April 30, 2012 and Friday, May 4, 2012.

Rationale for Changes

The above two revisions from the last November 22, 2011 change notice are required because the State Education Department has finally just released revised testing dates, scoring leader training dates, and final receipt of scored testing data.

This unfortunately necessitates a further revision to our school calendar.

Wednesday, June 20, 2012*
